**RE: ALLOCATION OF CONTRIBUTIONS FROM 8:00A.M. MONDAY, JUNE 1, 2015 THROUGH 7:59 A.M. MONDAY, JUNE 6, 2016.**

*GIVE THIS TO THE PERSON RESPONSIBLE FOR PREPARING YOUR PAYROLLS AND PAYROLL TAX RETURNS*

Pursuant to Section 18.01 of Article XVIII of the Principal Agreement, the Trustees have allocated contributions as follows effective with payroll reports filed for June 1, 2015 through June 5, 2016. This change merely establishes the Apprentice Stipend Fund and HAS NO IMPACT ON the \$2.25 increase in the total wage and fringe rates in the prior notice.

**WAGE RATE** – “Gross Earnings” to which the 53.2000% contribution rate is applied includes straight time hours at \$45.00, time-and-a-half hours at \$67.50 and double-time hours at \$90.00. **PLEASE NOTE:** Foreman and general foreman premiums, of \$3.00 and \$6.00 respectively, are NOT included in “Gross Earnings” for EIT contribution purposes.

**ANNUITY PLAN** – This \$5.02 per hour is a non-taxable fringe benefit and is not to be included in taxable wages nor in “Gross Earnings”.

**N.E.B.F.** – This contribution is made separately. It should NOT be sent to Electrical Insurance Trustees.
